BRUNEI TMA TEMPORARY RESTRICTIONS (REF BRUNEI AIP : ENR 1.10, ENR 5.1)

1. Period

1.1 From 05 October 2017, 0001UTC to 07 October 2017, 1159UTC.

2. Submission of Flight Plans

2.1 All intended flights in the area indicated by the chart as Area R1 are required to submit the file flight plan.

3. Restriction to Apply

3.1 Area R1 is restricted to aircrafts which :

i/ have a discrete transponder code.

ii/ have filed flight plan

iii/ maintain communications with ATC.

3.2 All VFR flights are forbidden within the Area 'R1' except within lateral limit of Limbang CTR.

4. Vertical and Lateral Limits

4.1 i) Vertical Limit : SFC - 14,500ft

ii) Lateral Limit : A circle 17NM centred at Brunei International Airport ARP 045639.128N
1145542.071E

4.2 Radio Frequencies :

i/ 118.7Mhz Brunei Control Tower

ii/ 127.1Mhz Brunei Radar Centre

5. Establishment of Prohibited Area

5.1 Vertical and lateral limit :

i/ SFC – 3,000ft

ii/ Lateral : A circle of radius 3NM from coordinate 045322N 1145629E

5.2 All aircrafts are prohibited within the area indicated as 'P1' in Chart 'A' except for approved flights.

6. Implementation Dates

6.1 The AIP Supplement will become effective at 0001UTC on 05 October 2017 until 07 October 2017, 1159UTC

6.2 A Trigger NOTAM will be issued on 30 September 2017 notifying the effective date of temporary establishments.

7. Remarks

7.1 All flights to/from WBSB aerodrome are may be subjected to delay.

7.2 State aircraft and state flights are not affected by above mentioned restrictions.

7.3 Any unauthorized aircraft within the Area 'R1' and 'P1' may be subjected to interception by appropriate enforcement authority.

8. Conclusion

8.1 Any change to the contents of this AIP Supplement will be notified by NOTAM.
