# TEMPORARY PROCESS FOR SUBMISSION OF APPLICATION, PAYMENT METHOD AND DOCUMENT COLLECTION

#### 1. INTRODUCTION

- 1.1. This Notice details the temporary process established for submission of application, payment method and document collection for matters involving sections under Regulatory Division, Department of Civil Aviation.
- 1.2. This Notice is issued in the interest of protecting public health due to the current situation of COVID-19 pandemic in the country. In this regard, Regulatory and Finance counters will be temporarily closed effective immediately until a date to be announced later.
