# AMENDMENTS TO BRUNEI AVIATION REQUIREMENTS ON AERODROME – BAR 14

In exercise of the powers conferred by sections 7(a) and 35 of the Civil Aviation Order, 2006 and regulations 86 and 91(1) of the Civil Aviation Regulations, 2006, I, ABDUL GHANI BIN HAJI OTHMAN, the Acting Director of the Department of Civil Aviation hereby issue this Direction for the purpose of -

- I. notifying that Brunei Aviation Requirement on Aerodrome BAR 14 Volume I Aerodromes has been amended following adoption of ICAO Annex Amendment 14
- II. notifying that Brunei Aviation Requirement on Aerodrome Volume II Heliports has been amended following adoption of ICAO Annex Amendment 8
