



AVIATION SAFETY CIRCULAR

CIVIL AVIATION ACT & CIVIL AVIATION REGULATIONS

Pursuant to Section 6 of the Civil Aviation Act (CAP. 290), I, **MOHAMAD AZLAN MOHAMMAD JUNAIDI**, Acting Director of Civil Aviation, hereby informs that the following legislation has been revised and shall be cited in accordance with the amendments published in the government gazette:

- (a) **Civil Aviation Order 2006, S 63/2006 has been amended by S 76/2016 and shall be cited as Civil Aviation Act;** and
- (b) **Civil Aviation Regulations 2006, S 69/2006 has been amended by S 73/2014 shall be cited as Civil Aviation Regulations.**

The notable amendments are as follows:

- 1) Repeal of Section 14 (CAO 2006): The revised CAA repeals Section 14 of the CAO concerning rights in aircraft and detention of aircraft.
- 2) Expansion of Regulation 44 (CAR 2006): The revised CAR introduces a new definition of “areas with specified performance-based navigation” and expands Regulation 44 into **44A** and **44B**:

- i. **Regulation 44A** applies to aircraft registered in Brunei, which must not operate in designated performance-based navigation (PBN) areas unless:

- Equipped with approved navigation equipment;
- Operated by an approved operator; and
- In compliance with approved procedures.

Exception: Permitted if authorised by Air Traffic Control (ATC) and all instructions are followed.

- ii. **Regulation 44B** applies to foreign-registered aircraft operating in Brunei airspace, which must:

- Comply with their state of registry's PBN requirements; and
- Meet performance standards in functionality, accuracy, integrity, availability, and continuity.

Exception: Same as Regulation 44A.
