AMENDMENTS TO BRUNEI AVIATION REQUIREMENTS ON PERSONNEL LICENSING (BAR 1)

In exercise of powers conferred by sections 7(a) of the Civil Aviation Order, 2006 and regulations 86 and 91(1) of the Civil Aviation Regulations, 2006, I, **MOHAMAD AZLAN BIN MOHAMMAD JUNAIDI**, the Acting Director of the Department of Civil Aviation hereby issue this Direction for the purpose of notifying that Brunei Aviation Requirements on Personnel Licensing (BAR 1) have been amended:-
