ADOPTION OF PART ATCO.MED (MEDICAL REQUIREMENTS FOR AIR TRAFFIC CONTROLLERS) INTO BRUNEI AVIATION REQUIREMENTS – BAR 1

## AMENDMENTS TO BRUNEI AVIATION REQUIREMENTS ON AIR OPERATIONS - BAR 6

In exercise of the powers conferred by sections 7(a) of the Civil Aviation Order, 2006 and regulations 86 and 91(1) of the Civil Aviation Regulations, 2006, I, **MOHAMMAD NAZRI MOHAMMAD YUSOF**, the Acting Director of the Department of Civil Aviation hereby issue this Direction for the purpose of :

- (a) adopting Part ATCO.MED (Medical Requirements for Air Traffic Controllers) into Brunei Aviation Requirements BAR 1;
- (b) notifying that Brunei Aviation Requirements on Air Operations BAR 6 have been amended.

Please find attached the updated list of BAR 1 and BAR 6 documents.

Organisations affected by the new requirements are required to be in full compliance with those requirements by **31st January 2019**.
