DC.1 Introduction

DC.1.1 Pursuant to Civil Aviation Order 2006 and the Civil Aviation Regulations 2006 and their subsequent amendments, the following requirements are hereby established for compliance by all persons concerned, the Director of Civil Aviation is empowered to adopt and amend Brunei Aviation Requirements. In accordance herewith, the following AMC & GM is hereby established for compliance by all persons concerned. This AMC & GM shall be known as BAR1 Part-CC Cabin Crew - Acceptable Means of Compliance and Guidance Material and any reference to this title shall mean referring to these regulations governing the requirements to be met for the certification of personnel licensing.

DC.2 Authority for this Regulation

DC.2.1 This BAR1 Part-CC Cabin Crew - Acceptable Means of Compliance and Guidance Material is issued on the authority of the Director of Civil Aviation.

DC.3 Applicability

DC.3.1 This BAR1 Part-CC Cabin Crew - Acceptable Means of Compliance and Guidance Material is applicable to the aviation industry of the Brunei Darussalam.

DC.4 Scope

- DC.4.1 BAR1 Personnel Licensing AMC & GM Acceptable Means of Compliance and Guidance Material contains the acceptable means of compliance and guidance material for the personnel licensing regulations and shows compliance with ICAO Annex 1. The AMC & GM are separated into the following parts with cross references between parts where applicable.

 - Part ORA Organisational Requirements for Aircrew AMC & GM

Crew resource management training table

The CRM training table recapitulates all elements relevant to CRM training for cabin crew, specifying the following:

- (a) The elements of the introductory course on CRM required for the cabin crew initial training course, where 'in-depth' means a training that should be instructional or interactive in style taking full advantage of group discussions, team task analysis, team task simulation, etc., for the acquisition of knowledge, skills and attitudes.
- (b) The elements, identified as 'not required' for the cabin crew initial training, are listed for information as they are covered during other training in accordance with the applicable requirements of BAR 6 Part-ORO (organisation requirements for air operations).
