BRUNEI DCA DIRECTIVE FOR THE REQUIREMENTS ON DANGEROUS GOODS

1. Introduction

- 1.1. This Flight Operations Directive (FOD) details the Brunei DCA policy regarding the requirements for the Safe Transport of Dangerous Goods by Air;
- 1.2. The purpose of this directive is to ensure compliance to the relevant standards and requirements of ICAO Annex 18 (including ICAO Doc 9284) and Brunei Aviation Requirements (BAR) 18.

2. Scope

- 2.1. All entities listed below shall comply with this directives:
 - 2.1.1. All operators having their principal place of business in Brunei Darussalam and issued with the Aircraft Operating Certificate (AOC);
 - 2.1.2. Shippers and Freight Forwarder;
 - 2.1.3. Postal Operator;
 - 2.1.4. Ground Handling Agents; and
 - 2.1.5. Other entities specified in the standards and/or requirements.

3. Description

3.1 In accordance with Brunei Civil Aviation Regulations, 2006 (S 69/2006) Regulation 86, where there are inconsistency between the Tenth Schedule of the Regulations and BAR 18, the provisions in BAR 18 shall be followed.

4. Additional information

4.1. The department has issued Brunei Aviation Requirements on Safe Transport of Dangerous Goods by Air (BAR 18) through Aviation Safety

4.2. Dangerous Goods Requirement in BAR 6 Part ORO, CAT, SPA and SPO shall apply for all air operators.
