1. INTRODUCTION

1.1 The purpose of this notice is to update the operation hours of Personnel Licensing Section for applications, payments and collection matters.

2. PROCESS

- 2.1 All payments regarding licensing **shall only be paid to the Finance Section** (**Ground Floor**) DCA HQ before sending the application to PEL Section (Third Floor). Upon payment, the original receipt shall be attached with the application form and will be photocopied by PEL Section. Original receipt will be given back to the applicant on the day of collection. No payments shall be made to PEL Section.
- 2.2 Submission for Flight Crew Licence Validation and Air Traffic Controller Licence (ATCO) can be made by sending the complete application in-person to PEL Section (Third floor) or made via e-mail: e-licensing@dca.gov.bn
- 2.3 Submission for BAR 1 Part 66 Aircraft Maintenance Engineering Licence (AMEL) shall be made by sending the complete application in-person to PEL Section (Third floor).

- 2.4 All Application forms can be attained from 'Personnel Licensing' under form's tab in the department website at www.dca.gov.bn.
- 2.5 Licence application and payment operating hours:

Monday to Thursday 08.30 am until I 1.00 am

02.00 pm until 03.00 pm

Saturday 08.30 am until 10.30 am

2.6 Licence collection hours:

Monday to Thursday & Saturday 08.30 am until 12.00 noon

02.00 pm until 04.00 pm

Date and time of collection for the licenses and approval will be advised via e-mail upon issuance of licenses and approval. The collection will be at PEL Section (Third floor counter).
