



AVIATION SAFETY CIRCULAR 03/2019

AMENDMENTS TO BRUNEI AVIATION REQUIREMENTS ON AIR OPERATIONS (BAR 6)

In exercise of the powers conferred by sections 7(a) of the Civil Aviation Order, 2006 and regulations 86 and 91(1) of the Civil Aviation Regulations, 2006, I, **HAJI AWANG BUJANG BIN HAJI TINKONG**, the Acting Director of the Department of Civil Aviation hereby issue this Direction for the purpose of -
