



## AVIATION SAFETY CIRCULAR 05/2018

### AMENDMENTS TO BRUNEI AVIATION REQUIREMENTS ON ACCIDENT PREVENTION AND OCCURRENCE REPORTING – BAR 13

&

### THE PUBLISH OF INDIVIDUAL FORMS FOR MANDATORY OCCURRENCE REPORT (MOR) ON THE BRUNEI DCA WEBSITE

In exercise of the powers conferred by sections 7(a) and 52 of the Civil Aviation Order, 2006 and regulations 83, 86 and 91(1) of the Civil Aviation Regulations, 2006, I, **MOHAMMAD NAZRI MOHAMMAD YUSOF**, the Acting Director of the Department of Civil Aviation hereby issue this Direction for the purpose of -

- (a) notifying that Brunei Aviation Requirements on Accident Prevention and Occurrence Reporting – BAR 13 has been amended ;
- (b) notifying that individual forms for Mandatory Occurrence Report (MOR) are published on the Brunei Department of Civil Aviation website.

Please find attached the **updated list of BAR 13 document**.

Organisations affected by the new requirements are required to be in full compliance with these requirements by **31st January 2019**.


